The Portrait of a Senior Territorian Art Award recognises and celebrates the achievements and contributions by senior Territorians to our community.

Now in its 21<sup>st</sup> year, the Portrait of a Senior Territorian Art Award continues to foster excellence and creativity in the art of portraiture by artists who are residents of the Northern Territory.

The People's Choice Prize of \$1,000 is determined by public votes submitted across the exhibition period and announced on Friday 12 March 2021.

## **2020 PORTRAIT OF A SENIOR TERRITORIAN ART AWARD – TERMS AND CONDITIONS OF ENTRY**

### **ELIGIBILITY**

1. The Award is open to artists aged 17 years and over who are residents of the Northern Territory.
2. Collaborative works are acceptable provided the name of each collaborating artist is clearly stated on the entry form, and all collaborating artists have signed the form.

### **ENTRY**

3. Entry forms (and other required information) must be received by Araluen Arts Centre by  
5.00 pm CST, **Friday 23 October 2020**.
4. To be eligible for consideration, entry forms must be accompanied by:
  - a) an accurate statement of up to 100 words about the person who is the subject of the artwork and up to 100 words about the artist/s and their arts practice. These statements may be used in a catalogue (should one be produced), on exhibition panels, and in promotional material; and
  - b) a quality digital image of the completed artwork. The digital image must be in jpeg format, of no less than 300 dpi or 300 ppi, and be a maximum 4 megabytes.
5. The entry form, the two statements of up to 100 words each, and the digital image must be submitted via email to: [poast.coordinator@nt.gov.au](mailto:poast.coordinator@nt.gov.au).
6. The artwork must be completed at the time of entry.

### **THE ARTWORK**

7. The artwork must be an original painting by the entrant/s and completed no more than two years prior to the exhibition.
8. The Acquisition Award will be awarded to the best portrait in any 2D medium (excluding photography, digital media or bas relief), being a depiction of a particular living person, with the subject known to the artist and aware of the artist's intention.
9. The artwork must NOT exceed the size limit of 1.5 metres x 1.5 metres, including the mounting and/or frame.
10. The artwork may be a multi-panel work as long as the overall dimensions do not exceed the size limit stated in point 9, above.
11. The artwork may be painted in any 2D medium (e.g. oil, acrylic, watercolour, mixed media).  
This excludes photographic works, including digital media, prints and bas relief.

12. Only one entry per artist is permitted.
13. Artworks previously submitted to the Portrait of a Senior Territorian Art Award will not be accepted. This applies to previously submitted artworks that have been reworked.
14. Portraits must be of one or more living senior Territorians aged 60 years or over (as at 23 October 2020), who permanently reside in the Northern Territory.
15. Araluen Arts Centre reserves the right not to exhibit a work.
16. Finalists will be notified of their selection by **27 October 2020**.

### **PREPARATION AND DELIVERY OF ARTWORK**

17. Works that have been selected as finalists must be delivered by post, courier or in person to the Araluen Arts Centre at **61 Larapinta Drive, Alice Springs, NT** before 5.00 pm CST on **Friday 13 November 2020**. Deliveries are accepted between 10.00 am and 5.00 pm CST Monday to Friday.
18. Artworks not received by the prescribed date will be excluded from the exhibition and from consideration for the awards.
19. The artwork must NOT be wet when submitted.
20. The artwork must be suitably framed for handling and installation, including framing and stretching. However, the artwork must NOT include any hanging devices such as hooks or wires.
21. The artwork must be submitted with two printed copies of the completed entry form. One copy of the completed entry form must be attached to the back of the artwork.
22. If using a courier or mailing the artwork, a second copy of the completed entry form must be put in an envelope and also attached to the back of the work.
23. Freight costs to deliver the artwork are the responsibility of the artist.

### **INSURANCE**

24. The artist is responsible for transport of the artwork to and from the exhibition at the Araluen Arts Centre and for insuring the artwork during transit to and from the exhibition space at the Araluen Arts Centre for drop-off or collection.
25. The Northern Territory Government and its agencies accept no responsibility for late or misdirected entries.

26. During the exhibition period at the Araluen Arts Centre, artworks will be insured by the Northern Territory Government against loss or damage, up to the sale price of the artwork or the value of the Acquisition Award, whichever is the lesser. Additional insurance for works with a sale price over the value of the Acquisition Award is the responsibility of the artist.

## **AWARD INFORMATION**

27. The \$7,000 Acquisition Award is provided in exchange for the winning artwork, which will be selected by a panel of judges and acquired by the Northern Territory Government.
28. A panel of judges will be announced closer to the exhibition date.
29. The use of appropriate archival materials may be taken into account by the judges of the Acquisition Award.
30. Any artwork deemed to need excessive ongoing maintenance will not be considered for the Acquisition Award.
31. Artworks that are not available for sale will not be eligible for the Acquisition Award.
32. Any artwork priced above the \$7,000 value of the Acquisition Award will be considered for the Acquisition Award only if the entrant has specifically indicated their consent on the entry form.
33. The \$2,000 Second Prize and \$500 Third Prize non-acquisitive awards will also be selected by the panel of judges.
34. The \$1,000 People's Choice Prize (a non-acquisitive award) will be decided by public ballot. The winner of the People's Choice Prize will be the artist whose work attracts the highest number of votes.
35. Winners (except People's Choice Prize) will be announced at the opening of the Award at the Araluen Arts Centre on Friday 4 December 2020.
36. No correspondence will be entered into concerning the judges' decisions.
37. The People's Choice Prize will be announced on Friday 12 March 2021.
38. Prizes will be presented to the winning artists or their authorised representatives.
39. Payment of prize monies will be coordinated by the Araluen Arts Centre in accordance with Northern Territory Government protocols.
40. Where an award is conferred on a work with collaborating artists, the award value will be split evenly between those artists.

## **SALE OF ARTWORK**

41. A price list of works will be made available and the contact information of the artist (or their nominated representative) will be provided to potential buyers to facilitate the purchase.

## **COLLECTION OF ARTWORKS**

42. All works will be held for the duration of the exhibition and will not be released until the specified collection date under any circumstances.
43. All sold works must be collected by the buyer or their agent from the Araluen Arts Centre. Where works cannot be collected in person, freight from the exhibition venue for purchased works is the responsibility of the buyer.
44. Unsold works may be collected in person by artists or their agent.
45. Where unsold works cannot be collected in person, the artist must make arrangements to have the artwork collected from the Araluen Arts Centre. Freight from the exhibition venue for unsold artwork is the responsibility of the artist.
46. Artworks will be released for collection on Monday 15 March 2020 and must be collected on this day from the Araluen Arts Centre between the hours of 10.00 am and 5.00 pm CST. Where an agent collects a work on behalf of an artist, the artist must provide collection authority advice, in advance of the collection, to the Araluen Arts Centre via email: [poast.coordinator@nt.gov.au](mailto:poast.coordinator@nt.gov.au).
47. Detailed instructions for collection of unsold works will be provided to each finalist prior to 8 March 2021.
48. Unsold artworks that are not collected within four weeks from the close of the exhibition will be deemed to be the property of the Araluen Arts Centre and may be dealt with at the discretion of the Araluen Arts Centre, including disposal.

## **COPYRIGHT, REPRODUCTION AND PERMISSIONS**

49. The artist warrants that the work is original and that it does not infringe any copyright, moral rights, intellectual property rights or other rights of any third party.
50. The artist remains the copyright owner of the work and will be acknowledged as the creator of the work at all times.
51. The artist grants to the Northern Territory Government a non-exclusive, perpetual, worldwide licence to freely use, reproduce, publish and communicate the selected work for publicity, promotional and educational purposes associated with the Award in print and digital media. The winning works may also be reproduced to promote future Portrait of a Senior Territorian Art Awards.

52. The work will be documented by the Northern Territory Government for archival and educational purposes.
53. The artist grants the Northern Territory Government permission to provide the media with photos and information about the artwork and artist for the purpose of promoting or reporting on the exhibition or award recipients.
